1. The Chairman opened the meeting by thanking everyone for attending. He said that the meeting had been called to form an amenity society for Yateley and that a steering committee drawn from the Yateley Study Group had prepared plans for the society over the previous nine months. Later nominations would be required if it was decided to form the society.

The Chairman went on to explain the background to the Yateley Study Group and to introduce the members of the steering committee.

Copies of papers were distributed comprising the agenda and a model constitution with suggested subscriptions etc.

- 2. Edward Dawson gave a short talk outlining the work of the Civic Trust and of an amenity society, its objectives and its constitution.
- The project's already being undertaken by the Yateley Study Group were detailed by the project leaders; Peter Tipton on Local History, Susan Dawson on Natural History and Edward Brooks on Conservation.
- 4. The Chairman then invited questions prior to the formal adoption.
- 5. The motion to form The Yateley Society was put to the meeting and was adopted as follows:-

"This meeting resolves than an amenity society to be known as The Yateley Society be formed."

6. The motion to adopt a constitution based on the model with proposed insertions, was put to the meeting and was adopted unanimously as follows:-

"This meeting resolves that the constitution presented at this meeting be adopted."

A copy of the model adopted is attached.

Mr. Tony Hocking answered a question from the floor regarding the proposed budget for the coming year.

7. Appointment of officers and members of the Executive Committee: The Chairman then called for nominations.

After some discussion during which several nominees offered to step aside in favour of fresh names, Mr. J. Davies proposed that a special general meeting be arranged in the near future (three months) to give new members of the Society the opportunity of assessing the worthiness of those proposed to serve on the committee. The proposition was seconded by Mr. Cooper. The Chairman put the proposition to the floor; five were in support with the majority of the meeting against. The Chairman then called for volunteer 'nominees' but none spoke. Agnes Stephenson proposed that the committee, as suggested by the Chairman, be appointed 'en bloc'. The proposition was seconded by Pat Saunders and received majority support from the meeting.

Mr. Tyler asked whether any officers or members of the Executive Committee had any professional or financial interests which should be declared. All gave details of their professions or occupations which showed that no declarations appeared necessary.

8. The resolution to change the title of the bank account, as detailed below, was unarimously approved by the meeting.

"This meeting resolves that The Yateley Study Group should in future be known as The Yateley Society and therefore that the bank account of the Yateley Study Group opened as a result of the resolution of 8 October 1980 should be renamed The Yateley Society. Alternatively at the discretion of Barclays Bank Limited, The Yateley Study Group account should be closed and a new account opened in the name of The Yateley Society authorised signatories being the holders of the same offices as before."

9. The Chairman gave details and information regarding the programme, membership and registration procedure.

- 10. Edward Dawson took the chair and invited questions from the floor. Comments and suggestions from the floor were noted.
